CONTACT FUNERAL HOME	NOTIFY ATTORNEY ABOUT PROBATE
CONTACT YOUR CLERGY	OF THE ESTATE

- ARRANGE FOR CARE OF DEPENDENTS ALERT FAMILY, CLOSE FRIENDS, &
- ARRANGE FOR CARE OF LIVESTOCK OR PETS **EMPLOYER**
- LOCATE LOVED ONE'S IMPORTANT ALERT EXECUTOR OF YOUR LOVED **DOCUMENTS (SEE BELOW)** ONE'S WILL
- **COMPILE INFORMATION NEEDED NOTIFY ANY ORGANIZATIONS YOUR** FOR DEATH CERTIFICATE (SEE BELOW) LOVED ONE WAS INVOLVED IN

ONE MONTH FOLLOWING THE DEATH

CONSULT WITH ATTORNEY AROUT PROBATE	OBTAIN COPY OF DECEASED'S CREDIT REPORT

- MEET WITH ACCOUNTANT TO DISCUSS ESTATE IF DEATH WAS ACCIDENTAL, CHECK FOR WEATHER **TAXES** BENEFITS ON INSURANCE POLICIES
- FILE LIFE INSURANCE CLAIMS CHECK FOR LIFE INSURANCE BENEFITS
- CONTACT SOCIAL SECURITY AND OTHER FILE HEALTH INSURANCE CLAIMS **GOVERNMENT OFFICES THAT MAY HAVE** BEEN MAKING PAYMENTS TO THE DECEASED **OBTAIN DECEASED'S OUTSTANDING BILLS**
- NOTIFY THE REGISTRAR OF VOTERS LOCATE PAPERWORK FOR ESTATE SETTLEMENT
- (SEE BELOW) IF THE DECEASED'S HOME IS UNOCCUPIED,
 - ADVISE CREDITOR THAT A DEATH HAS OCCURED CANCEL UNNECESSARY SERVICES
 - CHANGE OWNERSHIP OF ASSETS AND CREDIT LINES CANCEL DECEASED'S PERSCRIPTION
 - UPDATE YOUR WILL & BENEFICIARIES OF YOUR LIFE INSURANCE
 - SEND ACKNOWLEDGMENT CARDS & THANK **PALLBEARERS**
 - CANCEL SUBSCRIPTIONS, MAILING LISTS, AND SOCIAL MEDIA
 - ARRAGE FOR MARKET DISTRIBUTON OF CROPS & LIVESTOCK
 - ARRAGE HELP PLANTING/HARVESTING CROPS
